The Organizers reserve and the Exhibitor irrevocably submits to the non-the right in the case of Force Majeure (as defined in exclusive jurisdiction of the P.R. China Courts.

Article 18), orders/directives imposed by any government authority or any other unforeseen circumstances to cancel, postpone, alter in character, reduce in scale, shorten or extend the duration of the Exhibition at any time without incurring any liability whatsoever to the

contract or to claim against the Organizers or their agents or representatives, whether for loss or damages, or return of all or part of any money paid by the Exhibitor even if waives his right to the stand area allocated to him, Clause 9 of the Conditions of

The Organizers shall not be liable for any losses 13.3 The Exhibitor undertakes to indemnity and at all sustained or disadvantages suffered by the Exhibitor times thereafter to keep indemnified the Organizers as a result of postponement, curtailment, extension cance Exhibitors shall be given space in the alternative exhibition, if any, on a proportional basis. However the allocation shall be made as deemed appropriate by the Organizers in their absolute discretion and they shall not be liable for any further compensation to the Exhibitor. Rather, the Exhibitor shall in such case be required to prepare for such event.

> Where the Exhibitor has placed orders with the Organizers for services supplementary to those red by the participation fee (Clause 5), he shall be billed for the costs incurred until this point in time.

17 Force Majeure

'Force majeure" shall mean all events which are 13.5 The Exhibitor shall take out insurance policies to beyond the control of the Organizers, and which shall include earthquakes, typhoons, flood, fire, war, outbreak of disease, social unrest, act of government or any other events which cannot be foreseen. prevented or controlled, including events which are accepted as Force Majeure in general international commercial practice.

18. Final Provisions

In submitting the registration, the Exhibitor agrees to be bound by these Conditions of Participation, Any other agreements, individual permits or arrangements shall require written confirmation by the Organizers.

The English text shall be binding. Falling other arrangements subject to the prior consent of the Organizers, place of performance for payments is P.R. China.

Should any of the above items be or become invalid. this shall not affect the validity of the remaining terms: the resulting gaps shall be filled in such a way as to maintain the sense and purpose of the contract.

The Organizers reserve the right to interpret, after and amend any of these Conditions and to issue additional rules and regulations at any time they consider necessary for the orderly operation of the Exhibition. All interpretations of these Conditions and any additional rules and regulations by the Organizers shall he final

Any claims of the Exhibitors against the Organizers shall be barred after six months. The period of limitation shall commence with the end of the month in which the event chose.

Exhibitors shall bear all costs and expenses (including legal costs on a full indemnity basis) incurred by the Organizers in the recovery of any monies payable to it by the Exhibitors or in the enforcement of any terms of these conditions

Time shall be of the essence of the contract in relation to all the provisions of these conditions as shall relate to the payment of any monies from the Exhibitor to the Organizers.

All notices, demands or other communications required or permitted to be given or made under these Conditions shall be in writing and delivered personally or sent by prepaid registered post or facsimile addressed to the intended recipient thereof at its address specified in these Conditions or in the Application Form (as the case may be), or such other address notified by such party. Any such notice, demand or communication shall be deemed to have been duly served (if delivered personally or given or made by facsimile) immediately or (if given or made by letter) two days after posting and in proving the same it shall be sufficient to show that the envelope containing the same was duly addressed, stamped and posted

19. Governing Law

These Conditions shall be governed by and constructed in all respects in accordance with law of P.R. China
